ORDINANCE 2015-01

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER XXVI HOUSING AND PROPERTY MAINTENANCE OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF BELMAR, IN THE COUNTY OF MONMOUTH, NEW JERSEY

WHEREAS, the Borough of Belmar now desires to amend and supplement specific provisions with regard to summer rental inspection fees in Section 26-5, FEES, of the Borough of Belmar Revised General Ordinances.

NOW, THEREFORE, BE IT ORDAINED by the Borough of Belmar, County of Monmouth, New Jersey, that Chapter XXVI Housing and Property Maintenances of the Borough of Belmar Revised General Ordinances are hereby amended and supplemented as follows:

SECTION I. The following sections of 26-5, Fees, shall be amended as follows:

e. Reinspection Fees.

- 3. If an inspection is taking place prior to Memorial Day weekend the Code Enforcement office shall perform a second inspection or reinspection if necessary before Memorial Day.
- 4. If a third inspection is required there shall be no guarantee that the inspection will occur before Memorial Day weekend.

SECTION II. If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudicated and the remainder of the Ordinance shall be deemed valid and effective.

SECTION III. All Ordinances or parts of ordinances inconsistent with or in conflict with the ordinance are hereby repealed to the extent of such inconsistency

ORDINANCE 2015-02

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER XVI, POLICE REGULATIONS, OF THE GENERAL ORDINANCES OF THE BOROUGH OF BELMAR PERTAINING TO HOTELS, MOTELS & ROOMING HOUSES

WHEREAS, the Borough of Belmar finds that it is in its best interest to regulate the occupancy and registry for Hotels, Motels and Rooming Houses within the borough;

WHEREAS, the Borough of Belmar seeks to add a section to Police Regulations to add provisions for said regulation;

NOW, THEREFORE BE IT ORDAINED by the Borough of Belmar, County of Monmouth, New Jersey that Chapter XVI, Police Regulations, of the Borough of Belmar, Revised General Ordinance is amended and supplemented as follows:

SECTION I. Chapter XVI shall have the following section 26 added in its entirety:

16-26.1 Definitions

As used in this chapter, the following terms shall have the meanings indicated:

EMPLOYEE

Any person who is employed either full or part time, at any hotel or motel, in any capacity.

HOTEL

Any building, including but not limited to any related structure, accessory building, and land appurtenant thereto, and any part thereof, which contains 10 or more units of dwelling space or has sleeping facilities for 10 or more persons and is kept, used, maintained, advertised as, or held out to be a place where sleeping or dwelling accommodations are available to transit guests.

MOTEL

A "hotel" with individual entrances from the exterior of the building to each room or unit.

OWNER

Any person who owns, purports to own or exercise control of any hotel or motel.

ROOMING HOUSE

Any building, including buildings arranged or occupied for lodging, with or without meals, for compensation and not occupied as a one-family dwelling or a two-family dwelling.

PERSON

Any individual, group of individuals, corporation, association or other legal entity.

16-26.2 Prohibitions

The following acts or activities be and the same are hereby prohibited at any hotel or motel:

- a. No owner or employee shall rent a room or unit in any hotel or motel to any person, nor permit, suffer or allow the renting of any room or unit to any person for less than a period of 12 hours.
- b. No owner or employee shall rent a room or unit in any hotel or motel to any person, nor permit, suffer or allow the renting of any room or unit to any person for a period of time which exceeds 30 days.

16-26.3 Keeping of Registry

a. Every person operating a hotel or motel in the Borough of Belmar shall keep therein at all times a standard hotel register in which shall be printed legibly the true name and home address of each and every guest or person renting or occupying a room or rooms therein. The names of such guests shall be written upon the register by the persons themselves, and if they cannot write, the names shall be written in by the person renting the room or rooms, stating that the persons occupying such room could not sign their names. The person renting the room shall also require each person over the age of 18 occupying such room or rooms to display to the person in charge of the register one government-issued photo identification, such as a

driver's license, or not less than two other forms of valid identification. The form of identification that is produced shall be recorded, as well as any information from the identification that differs from the information supplied by said person renting the room. The register shall also include the registrant's home address and telephone numbers and the state license number of any motor vehicle then being used by or operated by the registrant, including the make, model and color of the vehicle, and the person renting the room shall thereupon write, opposite the name so registered, the number of the room or rooms assigned to each guest and the time when the same is rented, whether a.m. or p.m. The register shall be signed by the person renting the rooming unit and shall show the date of registration and the date when the occupant of each room shall surrender the room. Until all such entries have been made in such register, no guest shall be permitted to occupy privately any room in the house. If the registrant does not write in the register the information herein required as to the motor vehicle, it shall be the duty of the operator or a duly authorized employee to write in said information. At any time any room or rooms are surrendered, it shall be the further duty of the agent to enter the time thereof in the register opposite the names of all official persons making such surrender.

- b. The register shall be available at all times to any code enforcement or police officer of the Borough upon request.
- c. No person under the age of 18 shall be permitted to rent a room without the permission of a parent or legal guardian. If the parent is not present at the time the room is rented, the minor shall present proof, in writing, of parental consent, the parent's name and telephone number and a legal form of identification, as set forth in Subsection A above, of the parent authorizing the registration.
- d. Each Room can only have the legal limit of adults set by Code Enforcement and the State of New Jersey excepting for minor children and handicapped persons that must be cared for.

16-26.4 Enforcement

a. The Code Enforcement Official or his or her designee is hereby designated as the local enforcing agency of the provisions of this ordinance applicable to motels, hotels or rooming houses having 10 or more sleeping rooms for guests under the authority vested in him or her at N.J.A.C. 5:10-23.1 The Police Department and any law enforcement agency in whose jurisdiction any of the above-mentioned places may be located may inspect such place at any hour to see that the register requirements of this ordinance are being complied with (N.J.S.A. 29:4-2).

16-26.5 Penalty

a. The penalty for violation of the foregoing provisions shall be a fine not less than \$500 nor more than \$5,000.

SECTION II. If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

SECTION III. All Ordinances or parts of ordinances inconsistent with or in conflict with the ordinance are hereby repealed to the extent of such inconsistency.

SECTION IV. This Ordinance shall take effect 20 days after final passage, adoption and publication according to law

ORDINANCE 2015-03

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER XX LICENSES-GENERAL OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF BELMAR, IN THE COUNTY OF MONMOUTH, NEW JERSEY, SECTION 20-9, GAMES OF CHANCE

WHEREAS, the Borough of Belmar now desires to amend and supplement specific provisions with regards games of chance of the Borough of Belmar Revised General Ordinances.

WHEREAS, the Mayor and Council of the Borough of Belmar have determined that these changes are necessary and proper to allow the Borough to more efficiently apply and enforce provisions of the Borough's Ordinances.

NOW, THEREFORE, BE IT ORDAINED by the Borough of Belmar, County of Monmouth, New Jersey, that Chapter XX Licenses-General of the Borough of Belmar Revised General Ordinances are hereby amended and supplemented as follows:

SECTION I. Section 20-9 shall be amended as follows:

20-9 GAMES OF CHANCE ON SUNDAY

Pursuant to N.J.S.A. 5:8-58, games of chance under the "Raffles Licensing Law" of the State of New Jersey (N.J.S.A. 5:8-50 et seq.) may be conducted within the Borough on the first day of the week, commonly known and designated as Sunday.

20-9.1 GAMES OF CHANCE APPROVAL PROCESS

The Borough Clerk is hereby delegated the authority to act as the "issuing authority" for the purpose of approving the granting of licenses for games of chance.

20-9.2 GAMES OF CHANCE ON SUNDAY

Pursuant to N.J.S.A. 5:8-58, games of chance under the "Raffles Licensing Law" of the State of New Jersey (N.J.S.A. 5:8-50 et seq.) may be conducted within the Borough on the first day of the week, commonly known and designated as Sunday.

20-9.3 APPLICATION REQUIRED

- (a) The issuing authority shall approve or deny all applications for bingo or raffle licenses with due expedition after the filing of the application. Applications must be filed with the Borough Clerk together with required fees pursuant to law. The applicant shall demonstrate in writing compliance with the provisions of all applicable laws and regulations.
- (b) No license to conduct a game of chance as authorized by law shall be issued to any organization not having a bona fide sites established in good faith within the State of New Jersey and actively engaged in serving one or more of the authorized purposes as defined by the rules and regulations of the Legalized Games of Chance Control Commission.

SECTION II. If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudicated and the remainder of the Ordinance shall be deemed valid and effective.

SECTION III. All Ordinances or parts of ordinances inconsistent with or in conflict with the ordinance are hereby repealed to the extent of such inconsistency
