#### RESOLUTION TEMPORARILY ALLOWING THE USE OF OUTDOOR EATING AREAS DURING THE BELMAR & LAKE COMO ST. PATRICK'S DAY PARADE FOR THE BOROUGH OF BELMAR, MONMOUTH COUNTY, NEW JERSEY

WHEREAS, businesses in the Borough of Belmar may obtain approval from the Planning Board or Zoning Board of Adjustment ("Board") for an Outdoor Eating Area, Outdoor Dining Area, or Sidewalk Dining Area ("Outdoor Eating Areas") pursuant to Ordinance Section 40-7.8(h) of the Belmar Development Regulations, and, if approval is granted, the Outdoor Eating Areas may only be utilized from April 1 to November 1 of each year, per 40-7.8(h)(11); and,

WHEREAS, businesses in the Borough of Belmar experience an exceptional demand for space during the Belmar & Lake Como St. Patrick's Day Parade ("Parade"), and have requested to use their approved Outdoor Eating Areas temporarily for the day of the Parade which, this year, is on Sunday, March 2, 2014; and,

**WHEREAS**, the Mayor and Council have allowed the use of approved Outdoor Eating Areas for the day of the Parade on an informal basis in the past and wish to allow the use of these areas this year by a written Resolution, to create uniform conditions and by the use of a written Resolution to ensure the businesses know what the conditions are; and

**WHEREAS**, the Mayor and Council wish to temporarily allow businesses to use approved Outdoor Eating Areas for the day of the Parade only under the conditions set forth below.

**NOW, THEREFORE, BE IT RESOLVED** by the Borough of Belmar, County of Monmouth, New Jersey, that businesses may temporarily use approved Outdoor Eating Areas for the day of the Parade only under the following conditions:

- 1. The Outdoor Eating Area, Outdoor Dining Area, or Sidewalk Dining Area ("Outdoor Eating Areas") must have received the appropriate approvals from the Belmar Planning Board or Zoning Board of Adjustment ("Board").
- 2. The business must comply with all Board conditions on the use of the Outdoor Eating Area.
- 3. The business may not set-up their Outdoor Eating Areas before noon on Saturday, February 21, 2015 and the Outdoor Eating Areas shall be closed down and cleaned up not later than noon on Monday, March 2, 2015.
- 4. Businesses without a Liquor License shall not permit the consumption of alcoholic beverages by individuals bringing their own alcoholic beverages, known as "BYOB," in the Outdoor Eating Area. These businesses shall provide sufficient staff to ensure no violations of this condition occurs, violations will result in the issuance of summonses.
- 5. Businesses with a current, valid Liquor License shall not permit the service or consumption of alcoholic beverages in the Outdoor Eating Areas. These businesses shall provide sufficient staff to ensure no violations of this condition occurs, violations will result in the issuance of summonses and/or Alcoholic Beverage Control charges.
- 6. Any business which violates these conditions and/or Board conditions on the use of the Outdoor Eating Area during the Parade, may upon Order of the Chief of Police or his designee, have their Outdoor Eating Area immediately shut down, and all persons shall vacate the Outdoor Eating Area.

Be it ordained by the Mayor and Council of the Borough of Belmar, in the County of Monmouth, State of New Jersey, as follows:

**SECTION I.** Chapter XXI, Taxicabs, is hereby amended as follows:

#### 21-5.2 Owner's License.

- a. —Any <u>Autocab/Pedicab</u> Owner's License issued pursuant to the terms of this Chapter shall expire at midnight on December 31 of the year in which it was issued, and may be transferable to a related business entity, such as in the case of a change in the form of a business entity or the purchaser or sale of all or part of a business entity, provided that the new owner complies with Section 21-6 Applications for Licenses and Section 21-7 Fees.
- b. Any Taxicab Owner's License issued pursuant to the terms of this Chapter shall expire at midnight on December 31 of the year in which it was issued and may be transferable pursuant to Section 21-6.1(d) Issuance of Licenses.

#### **21-6.1** Application Form.

Each applicant for the issuance or renewal of any form of license shall supply in full the information requested on application forms adopted by the Borough Council and obtained from the Department of Code Enforcement and shall verify the correctness thereof by his/her oath or affirmation. He/she shall file the completed application with the Department of Code Enforcement together with the full amount of the proper fee hereinafter fixed.

#### 21-6.1 Issuance of Licenses

- a. The Municipal Clerk is authorized to advertise for sale ten (10) yearly licenses and ten (10) summer licenses in accordance with N.J.S.A. 48:16-2.1 et seq. Such licenses shall be offered at public auction, after advertising thereof in the official newspaper.
- b. The minimum bid price shall be set by resolution of the Governing Body annually.
- c. Ten percent (10%) of the minimum bid price shall be paid to the Municipal Clerk by certified check or cash prior to the public auction beginning. The balance shall be paid within ten (10) days of the adoption of the Governing Body's resolution accepting bids. The Governing Body reserves the right to reject all bids where the highest bid is not accepted.
- d. Any new license issued pursuant to this section may not be transferred within two (2) years after issuance unless such transfer is approved on the basis of death, disability, serious illness, or severe financial hardship by resolution of the Governing Body.

# 21-6.2.1 Applications.

a. —Applications for new Taxicab/Autocab/Pedicab Owner's Licenses shall be filed with the <u>Municipal Clerk Department of Code Enforcement</u> no later than thirty (30) days prior to the date action is requested on the license application from the Borough Council. If the maximum number of Taxicab/Autocab/Pedicab Owner's Licenses have been issued, no new licenses shall be approved before an existing license is surrendered to the Municipal Clerk Department of Code Enforcement.

b. Applications for new Taxicab Owner's Licenses per section 21-6.1 of the Borough of Belmar Revised General Ordinances shall be filed with the Municipal Clerk within ten (10) days of the adoption of the Governing Body's resolution accepting bids.

#### 21-6.2.2 Renewals.

- a. —Applications for Taxicab/Autocab/Pedicab owner's license renewals shall be filed with the <u>Municipal ClerkDepartment of Code Enforcement</u> no sooner than November 1 and no later than December <u>31</u><sup>4</sup> of the year preceding the year for which application is being made. All applications for renewals shall be acted upon prior to any consideration being given to new applications, which shall be considered in the order of their filing with the <u>Municipal ClerkDepartment of Code Enforcement</u> on a first come/first served basis. Any application for renewal received after December <u>31</u><sup>4</sup> of any year shall be treated as an application for a new license.
- b. Taxicab Owner's Licenses are not subject to renewal and shall be placed for public auction by the Governing Body annually.

#### 21-6.4 Processing of Applications.

The Department of Code Enforcement shall, after receipt of any complete application for an owner's or driver's license, notify the Borough Council in writing of the name and address of the applicant and the type of license sought, and shall post a copy of the notice in at least one (1) public place in the Borough at least seven (7) days before the Borough Council acts upon the application.

#### 21-6.5 Action by Borough Council.

The Borough Council, by resolution, shall act upon the application at their second meeting after receipt of the notice from the Department of Code Enforcement, and shall either grant or deny the application unless they decide to hold the same over for further investigation.

#### 21-6.6 Issuance of Licenses.

Each applicant granted a license under this Chapter shall be issued a license card in evidence thereof in a form approved by the Borough Council and signed by the <u>Code Enforcement</u> <u>OfficerMunicipal Clerk</u> in behalf of the Council.

**<u>SECTION II.</u>** If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**<u>SECTION III.</u>** All Ordinances or parts of ordinances inconsistent with or in conflict with the ordinance are hereby repealed to the extent of such inconsistency.

#### **ORDINANCE 2015-11**

## AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER XXXIV SPECIAL IMPROVEMENT DISTRICT OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF BELMAR, IN THE COUNTY OF MONMOUTH, NEW JERSEY

WHEREAS, the Borough of Belmar Mayor and Council wish to amend certain sections of Chapter XXXIV, Belmar Special Improvement District

**NOW, THEREFORE, BE IT ORDAINED** by the Borough of Belmar, County of Monmouth, New Jersey, that Chapter XXXIV, Belmar Special Improvement District, of the Borough of Belmar Revised General Ordinances are hereby amended and supplemented as follows:

**SECTION I.** Chapter XXXIV is hereby amended and supplemented as follows:

#### 34-5 ASSESSMENTS.

- a. It is hereby determined that the operation and maintenance of the District may involve annual costs relating to services peculiar to the District that are distinguished from operation and maintenance services normally provided by the Borough outside the District. Those annual costs shall be assessed to the benefited properties or businesses measured reasonably and fairly in proportion to the benefits conferred pursuant to this Chapter and N. J. S. A. 40:56-65 et seq. The properties to be assessed to provide for the payment of such annual costs are described in Section 34-4c. hereof and shall be assessed as provided herein, except
  - 1. Any organization organized under Section 501(c) of the Internal Revenue Code shall be at an amount not to exceed one hundred (\$100.00) dollars per year; and
  - 2. Any property which is owned by the Borough or any other public entity, which is leased pursuant to the Local Lands and Buildings Law N.J.S.A. 40A:12-1, to anyone other than another public entity or entity which is exempt from real estate taxation, the lessee shall pay an amount as determined by the District Management Corporation, however there shall be no assessment for any boat leases at the Belmar Marina; and
  - 3. All properties known as bed and breakfasts or rooming/boarding houses, included in 34-4c. and which hold a duly issued Belmar Mercantile License for the same shall be assessed at fifty (50%) percent of the maximum assessment rate needed to support the budget as determined by the District Management Corporation.
  - 4. Any commercial properties located west of Main Street and east of the Railroad from 13<sup>th</sup> Avenue to 16<sup>th</sup> Avenue, not to include Main Street facing properties shall be included in 34-4c and which hold a duly issued Belmar Mercantile License for the same shall be assessed at fifty (50%) percent of the maximum assessment rate needed to support the budget as determined by the District Management Corporation.

**SECTION II.** If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudicated and the remainder of the Ordinance shall be deemed valid and effective.

**SECTION III.** All Ordinances or parts of ordinances inconsistent with or in conflict with the ordinance are hereby repealed to the extent of such inconsistency

## AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER XIX, TRAFFIC, SECTION 19-40.1 PARKING METER ZONES AND REGULATIONS, OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF BELMAR, IN THE COUNTY OF MONMOUTH, NEW JERSEY

**WHEREAS,** the Borough of Belmar Mayor and Council wish to amend certain sections of Chapter XIX, Traffic.

**NOW, THEREFORE, BE IT ORDAINED** by the Borough of Belmar, County of Monmouth, New Jersey, that Chapter XIX, Traffic, of the Borough of Belmar Revised General Ordinances are hereby amended and supplemented as follows:

**<u>SECTION I.</u>** Chapter XIX is hereby amended and supplemented as follows:

# **19-40.1** Parking Meter Zones and Regulations.

The provisions of this subsection shall regulate the parking of vehicles within parking meter zones as hereinafter designated; the designation, use and operation of parking meters; and the payment of fees prescribed herein.

e. *Hours of Operation*. All parking meters installed on Ocean Avenue shall be in operation every day from 8:00 a.m. through 7:00 p.m.<u>.</u>

j. *Enforcement*. It shall be the duty of the members of the Belmar Parking Authority to enforce the provisions of this section.

**THEREFORE, BE IT ORDAINED** by the Borough of Belmar, County of Monmouth, New Jersey, that Chapter XIX Traffic, Section 19-38 Loading Zones of the Borough of Belmar Revised General Ordinances is hereby amended and supplemented as follows:

#### SECTION I. 19-38 Loading Zones

The locations described are hereby designated as Loading Zones. No person shall park a vehicle in these locations during the times indicated other than for the loading or unloading of goods and materials.

Street 12<sup>th</sup> Avenue <u>Side</u> North Location Beginning at the northwest corner of Highway 35 (River Road) 150 feet along the north curbline of 12<sup>th</sup> Avenue

**SECTION IL.** If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**<u>SECTION III.</u>** All Ordinances or parts of ordinances inconsistent with or in conflict with the ordinance are hereby repealed to the extent of such inconsistency.

#### **ORDINANCE 2015-14**

#### AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER XIX, TRAFFIC, SECTION 19-10 TEMPORARY PARKING PROHIBITION FOR SNOW PLOWING AND REMOVAL, OF THE GENERAL ORDINANCES OF THE BOROUGH OF BELMAR

WHEREAS, the Borough of Belmar desires to amend its ordinance to reflect new rules for parking on the street during a snow emergency.

**NOW, THEREFORE BE IT ORDAINED** by the Borough of Belmar, County of Monmouth, New Jersey that Chapter XIX, Traffic, of the Borough of Belmar, Revised General Ordinance is amended and supplemented as follows:

**SECTION I.** Chapter XIX, Section 19-10, Temporary Parking Prohibition for Snow Plowing and Removal.

a. Whenever snow <u>is anticipated has fallen</u> and the accumulation is such that it <u>would</u> covers the streets or highways, <u>the Mayor may make a determination that an emergency shall be deemed to exist and no vehicle</u> shall be parked on the streets or highways or portions thereof as provided herein. <u>Residents shall be given 24</u> hour notice of said determination by way of reverse 911 phone notification (e.g. Code Red) and posting on the borough's web-site.

- 1. All vehicles, whenever practicable, shall be parked off-street in driveways or in other permissible offstreet parking areas until both sides of the street have been plowed sufficiently and to the extent that parking will not interfere with normal flow of traffic...; or
- 2. If there is insufficient driveway space or insufficient space in other permissible off street parking areas, then all vehicles shall be parked on the side of the street containing even numbered properties; then, within twenty four (24) hours after the side of the street containing odd-numbered properties has been plowed sufficiently and to the extent that parking will not interfere with normal flow of traffic, all vehicles shall be moved to the side of the street containing odd-numbered properties until the streets have been plowed sufficiently and to the extent that parking will not interfere with normal flow of traffic.

b. Any unoccupied vehicle parked or standing in violation shall be deemed a nuisance and a menace to the safe and proper regulation of traffic and any police or code enforcement officer may ticket that vehicle. In the event of a state of emergency declared by the Governor of the State of New Jersey and the Mayor of Belmar, any police officer may provide for the removal of such vehicle. The owner shall pay the reasonable costs of the removal and storage which may result from such removal before regaining possession of the vehicle.

c. Any person, firm or corporation violating any of the provisions of this section shall, upon conviction thereof, shall be subject to <u>a penalty not to exceed one hundred and fifty (\$150.00) dollars</u>. the applicable penalty set forth below. Each and every day in which the violation exists shall constitute a separate violation.

1. For a first offense, within any one (1) calendar year, fifty (\$50.00) dollars, plus costs.

- 2. For a second offense, within any one (1) calendar year, one hundred (\$100.00) dollars, plus costs.
- 3. For a third or subsequent offense, within any one (1) calendar year, a mandatory Court appearance shall be required and a fine upon conviction of one hundred fifty (\$150.00) dollars up to the maximum amount provided for in Chapter I, Section 1-5, and the imposition of costs, as determined by the Court.

**<u>SECTION II.</u>** If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**<u>SECTION III.</u>** All Ordinances or parts of ordinances inconsistent with or in conflict with the ordinance are hereby repealed to the extent of such inconsistency.

**<u>SECTION IV.</u>** This Ordinance shall take effect 20 days after final passage, adoption and publication according to law.
