A Regular Meeting of the Mayor and Council of the Borough of Belmar held on the above date at **6:00 pm** at the Belmar Municipal Building, 601 Main Street.

RESOLUTIONS:

Mayor Doherty offered the following resolution for adoption: **2016-71, RESOLUTION APPOINTING ACTING CHIEF OF THE BELMAR POLICE DEPARTMENT WITH ADVICE AND CONSENT OF THE BOROUGH COUNCIL**, which was seconded by Council member Keown-Blackburn and approved by the following vote:

AYES: Magovern, Keown-Blackburn, Brennan, Nicolay and Doherty

Mayor Doherty administered the Oath of Office to Chief Huisman.

WORKSHOP DISCUSSION:

- BBP parking recommendations
 - O Tom Burke, member of the BBP, stated the BBP wants to work with the Mayor and Council to address the parking concerns in town. One suggestion is parking kiosks on 10th Avenue west of Main Street and in the Plaza. He presented a map that lists the parking areas near Main Street including time limits. The BBP feels it will be beneficial to try to work with the spots that we already have and make some changes. Suggested creating a commuter area near the train station.
 - O Council member Brennan stated most train stations charge for parking. It won't address the parking issues in the summer when it's crowded but feels it would be a good idea to charge the commuters who park there all day.
 - Council member Keown-Blackburn suggested a pick up and drop off area near the train station.
 Mr. Burke stated they had thought of a taxi stand and could expand on that.
 - o Mr. Burke also stated the parking lines and "no parking" designations on Main Street need to be repainted.
 - Council member Keown-Blackburn stated she wouldn't want residents to have to pay to park in the Plaza during the Friday and Saturday night concerts. She asked how many parking spaces are being taken up by employees of the business owners. Mr. Burke stated he did not know but the BBP plans on meeting with all the businesses to encourage them to use alternate transportation methods and keep the parking spaces in front of their stores open.
- Redevelopment Plan Amendment & Master Plan Re-Exam
 - O Dave Roberts, Maser Consulting, explained the 10 year time period for a master plan re-exam is expiring in August and the Planning Board is anxious to get started on it. Also in 2014 the Mayor and Council created an advisory committee to study the seaport redevelopment plan. This committee suggested the redevelopment area be extended to include additional areas of town. There is new redevelopment law that allows non condemnation redevelopment areas to be created. While the Planning Board is updating the master plan it's a good idea to also look into whether or not to expand and amend the redevelopment plan.
 - o Mayor Doherty stated it is important that everyone know there will be no use of eminent domain there will be no master redeveloper, and there is no coercion.
 - Council member Magovern asked about the process. It is a combination of the Planning Boards suggestions and Mr. Roberts' suggestions. Mr. Roberts stated the Mayor and Council is the one that decides whether or not to adopt the amended plan recommended by the Board.
 - o Council member Brennan asked about incorporating sustainability. Mr. Roberts stated that

element is already in the plan.

<u>PETITIONS:</u> Ms. Claudio stated she received a referendum petition on ordinance 2016-01 and has certified the petition to the Mayor and Council. Ms. Connolly stated on advice of Counsel she has rejected the petition.

Council member Keown-Blackburn: Thanked Recreation Director Ray Claudio for opening the gym to seniors to walk during the winter.

Council member Brennan: Thanked all those involved with the Belmar Elementary musical. Also thanked everyone for the birthday wishes.

Council member Nicolay: Congratulated Kelly and Billy Williams on the birth of their son. Wished Dennis Witkowski a Happy Birthday. Summer Camp is sold out. Announced upcoming St. Rose School, Arts Council and Belmar Elementary School events. BBP will be running a Belmar commercial again this year.

Mayor Doherty: He and Council member Magovern missed the last meeting because they were at the Whitehouse for the President's St. Patrick's Day celebration. Tomorrow is the ground breaking ceremony for the rebuilding of Taylor Pavilion. Thanked the current Council and former Council member Claire Deicke for their support in the rebuilding.
