## **REPORTS OF COUNCIL:**

Council member Magovern: Resident Thomas Smyth's wake and funeral is this week. Harbor Commission met and discussed a new trash collector for the water. Would like us to look into purchasing one or two. Historical Society will be holding a session where residents will tell stories of growing up in Belmar on March  $10^{th}$ . A meeting was held last week to coordinate Phase I of the Maclearie Park improvements. One topic discussed was the bathroom being mobile because a permanent structure would have to be built above the flood elevation. The plan also calls for a shade structure and the tennis courts being redone. Thanked everyone who supported him in the ALS plunge by raising \$1,000.

Council member Keown-Blackburn: The Council of Churches needs food for their food banks. There will be a donation box in Borough Hall in front of the gym. Belmar has been designated a Healthy Town to Watch by the State Mayor's Wellness Campaign. Met with Senator Booker's staff today regarding the platform at the train station being made ADA compliant.

Council member Brennan: Expanded on the trash collectors for the marina that Council member Magovern discussed. Can't wait to see a bathroom go in at Maclearie Park. Discussed the micro bead problem in the water that was in the Asbury Park Press today and how it happens.

Council member Nicolay: Congratulated Council member Magovern for doing the polar plunge. Belmar Elementary school has a Chopped contest this Thursday. Belmar Arts Council is now Belmar Arts Center. Encouraged everyone to attend one of their art shows. Little League registration is underway now. Thanked Chris VanSchoick for running the league for many years and doing a tremendous job. Anthony Latesta of Ma's Deli is now running the league.

Mayor Doherty: Also congratulated Council member Magovern. Read a post from a Republican website encouraging people to speak up at council meetings and smear the characters of the mayor and council. Feels it's an effort to try to bully the council. Also the idea of creating a public scene to the point of getting arrested is disappointing and low.

Second Reading & Public Hearing:

### **ORDINANCE NO. 2016-01**

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER IX, CONFLICTS OF INTEREST OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF BELMAR, IN THE COUNTY OF MONMOUTH, NEW JERSEY

Mayor Doherty recused himself and stepped off the dais.

Public Hearing: Ken Pringle, former Mayor, stated he is disappointed with this ordinance. Explained the purpose of the original ordinance such as dealing with contributions that could create conflicts with developers in the redevelopment zone and alcoholic beverage licenses and stopping pass through donations. Feels there is no reason to abandon the pass through language. Feels the changes benefit the Mayor in his campaign for Freeholder. Citizens United has no effect on the changes in this ordinance. He is not in support of an ordinance that will reduce the confidence the citizens have in their elected officials.

Council member Magovern stated the changes to the ordinance would apply to any political party running for local office.

Mr. Pringle stated changes are being made that don't need to be made. He added that while the Mayor's contributions would be for his county election it still has an effect on Belmar.

Michael Seebeck, 110 2<sup>nd</sup> Avenue, feels the ordinance allows people to contribute to campaigns anonymously by doing pass through contributions while our own residents cannot contribute anonymously.

Council member Magovern felt they are talking about "what ifs". He stated from his own experience he hasn't had big contributions from an outside group.

Katrina Clapsis, B Street, feels her concerns about this ordinance have increased. Feels the council doesn't fully understand the ordinance. Asked why the ordinance is being changed now. Feels nobody has suffered from this ordinance being in place. Feels this change will open Pandora's Box and cause the residents to constantly watch contributions. Suggested tabling the ordinance until after the Mayor's campaign to show that it has nothing to do with him.

Mike Druz, Ocean Avenue, asked why the original ordinance in 2004 was not filed with the Secretary of State. He stated if the Mayor wins his campaign than he won't be here anymore and therefore won't have any problems with influencing anything in Belmar. Asked if he has to follow local or county regulations. He added he doesn't see how Belmar can affect a county election.

David Schneck, 302 C Street, stated it doesn't matter what office anyone runs for because they still have the influence here while they are running. Suggested the mayor could resign so he is able to run for his campaign for Freeholder full time and then there won't be any problems. Also questioned how many contributions a local candidate needs for an election. He felt if the council really feels these changes are good and doesn't affect anyone specific that the ordinance could read that it doesn't go into effect until the incumbents are no longer holding their seat.

Joan Corallo, A Street, stated she doesn't have an opinion one way or the other but doesn't like the format of the ordinance.

Tom Fahy, 400 River Avenue, feels very strongly that the ordinance is wrong. Feels the stringent laws are in place for reason. Feels money buys influence. Ordinance only benefits companies and politicians, not the residents.

Council member Magovern made a motion to close the public hearing, which was seconded by Council member Brennan and approved unanimously.

Council member Magovern made a motion to adopt Ordinance 2016-01, which was seconded by Council member Nicolay and approved by the following vote:

Council member Keown-Blackburn stated she is torn. Feels there are some good things in the ordinance. Can always change the ordinance if it doesn't work out.

Council member Brennan clarified that it would be illegal for someone to give a check to a company and say give this to Belmar. Stated his main problem with the ordinance as it exists is that it puts Belmar at a disadvantage. Feels if someone wants to run for an outside election they should be able to do it at a level playing field.

Council member Nicolay felt the same as Council member Keown-Blackburn. Stated she hasn't had any problems with her election campaigns. She likes the idea of staying in line with county and state regulations.

Council member Magovern stated Mayor Pringle wrote a great ordinance but doesn't feel the changes being made are going to change the Belmar local election. Doesn't see Belmar being influenced by major contributors through pass through contributions.

of neighbors near a problem home which is now being sold. Council member Magovern stated there could be another problem house in the future.

# **PUBLIC SESSION:**

Claire Deicke 1017 14<sup>th</sup> Avenue, stated she is glad to hear we are pursuing a raised platform at the train station. Asked Council member Keown-Blackburn to explain the ADA Committee's mobility program. Anyone can donate or borrow mobility devices such as canes, wheelchairs, crutches etc.

David Marola, 817 12<sup>th</sup> Avenue, asked if a third trailer is being added to 13<sup>th</sup> Avenue. Mayor Doherty replied no. Ms. Connolly stated there were two there last year and will be two this year.

Tom Dilberger, 1000 River Road, stated NJ Transit is experiencing hard times financially. He asked about the bathroom for Maclearie Park. He asked why we don't just fix up the bathroom that's already there.

Tina Connelly, 612 13<sup>th</sup> Avenue, stated she came tonight because of the animal house ordinance that was tabled. She has a two family property next to her that is not an animal house but the quality of life is ridiculous. Her family is considering selling their house. She has tried speaking to the landlord but it doesn't work. Would like to see the ordinance passed.

Robert Cupoli, 402 9<sup>th</sup> Avenue, thanked Council member Keown-Blackburn for attempting to get a ramp or lift at the train station.

George Skudera, 1311 River Road, wanted to address some of the remarks made at the February 5<sup>th</sup> meeting regarding the paddleboard lease. Stated he didn't realize his speaking out would turn into a debacle. He had a poster documenting all of the violations of the paddleboard lease that he witnessed. He did not agree with Ms. Connolly's remark from that meeting stating the location of L Street Beach vs south end of Maclearie Park was splitting hairs. He suggested changes be made in the 2016 lease that include a sketch showing the location of the paddleboard lease on the L street beach.

Andy Maroney, 16<sup>th</sup> Avenue, asked questions about taking over Lake Como's police services. Asked how many extra officers would be hired to take on Lake Como. Mayor Doherty stated there is a presentation going on at Lake Como right now. Mr. Maroney asked what was done to determine how many officers would be needed. Mayor Doherty stated we worked with DCA and our police department. Mr. Maroney felt it is important to do a work load analysis. He felt we are causing Lake Como to lay off their police officers by putting an offer on the table. He also felt we are making the town unsafe. Mayor Doherty stated both of those statements are untrue. Mr. Maroney stated he didn't get one thing in the mail about this and how it's going to affect his everyday life.

Connie Dallaportas, 1002 Main Street, suggested something be built at the school bus stops for the children waiting to catch a bus in rain and snow.

Mayor Doherty made a motion to close the public session and adjourn the meeting, which was seconded by Council member Brennan and approved unanimously.
