<u>PUBLIC SESSION:</u> Public Session on resolutions only on the Agenda. We will continue to have a Public Session at the end of this meeting.

Tom Dilberger, 1000 River Road, asked what RFP stands for. Ms. Colleen stated it means request for proposal. He asked why one of the contracts is rejected. Mr. Kemm explained they cannot complete the process in the timeframe required. He went into more detail about the entire revaluation process.

Linda Chelsin, L Street, stated she thought we withdrew from the Monmouth County Demonstration Program. Mr. Kemm explained the difference between that program and the revaluation.

Tabitha Falcone, 1000 River Road, asked if a property could have two separate assessments; one from the county program and one from the revaluation. Mr. Kemm stated there could be two inspections but only the revaluation assessment would be used.

Tom Burke, 10th Avenue, asked how the revaluation affects those properties with a tax PILOT program. Mr. Kemm explained those properties still have an assessment and would be inspected.

Mr. Dilberger felt this is governmental invasion of privacy.

Peter Terranova, 800 B Street, suggested a letter go out to residents giving them information on the entire revaluation process.

Sandy Caputo, 1705 Surf Avenue, asked how the inspectors would be identified. She was concerned about letting people in her house. Ms. Connolly and Mr. Kemm stated they could speak to the vendor and come up with a plan. Council member Magovern suggested a special police officer go out with the inspectors.

Brendan Reed, 100 Ninth Avenue, asked if apartment units would be inspected as well. Mr. Kemm stated he was not sure but believed they may inspect individual units.

Council member Magovern made a motion to close the public session, which was seconded by Mr. Brennan and approved unanimously.
