REGULAR MEETING

A Regular Meeting of the Mayor and Council of the Borough of Belmar held on the above date at 6:00 PM at the Belmar Municipal Building, 601 Main Street.

WORKSHOP DISCUSSION:

- Recycling flyer, Mayor and Council will review and provide comments to Ms. Connolly and Ms. Claudio.
- Council member Magovern stated he has noticed properties in town putting down artificial turf. Concerned about whether or not it's permitted. Mayor Doherty would like Code Enforcement to determine how many properties have turf. Ms. Claudio stated turf is not permitted in area between sidewalk and curb as listed in the ordinance; there is no ordinance regarding having it on your property, however Zoning has determined it to be an impervious surface.
- Council member Brennan did more research on plastic bags. Some towns throughout the country are banning them entirely. Longport said they ordered bags for people to purchase and use instead of plastic bags. They don't enforce their ordinance. Would like to have an ordinance on this. Doesn't want to force merchants and tell them what to do but want to educate people more. Council member Walsifer suggested the BBP create signs for each business educating people first. Mayor Doherty was concerned about having an ordinance but not enforcing it. Council member Nicolay felt the ordinance may not help. She liked the idea of using signage. Mayor Doherty would like to try to figure out how many businesses use plastic bags. Council member Magovern asked if there is a reward for the businesses that don't use plastic bags.

Council member Magovern: February 13th is Historical Society show and tell program. Possible snow storm coming this week; would like to see a Code Red go out advising people to take their cars off the street.

Council member Walsifer: BBP is having their business Summit February 27th.

Council member Brennan: Would like to see Belmar be more environmentally active. Tomorrow is 15th annual sending district band concert at Manasquan High School.

Council member Nicolay: Little League registration has started. Visit Belmar Arts Center. Buy local.

Mayor Doherty: Congratulated and recognized Belmar Police Department and surrounding departments for the

recent arrest of two individuals. Captain Cox said his detectives did a great job. Tax Collector Robbin Kirk did a great job figuring out what properties are most affected by property revaluation. Company did a bad job determining assessments. Will be working with seven houses who assessments for land are \$750,000 when everyone around them is in the \$500,000 area. They need to do a joint appeal. Council member Brennan asked if anything would happen to the company who did the revaluations if it turns out many appeals are being won. Mayor Doherty felt it won't affect the County Tax Board's opinion.

Sandy Caputo, 1705 Surf Avenue, would like a copy of the map with the assessment errors posted on the website. Mayor Doherty stated we could email it to her.

Tom Volker, Eighth Avenue, asked if the updated assessments are posted online. Ms. Claudio replied yes.

Mike Seebeck, 110 Second Avenue, asked what the cost of the playgrounds was estimated from. Mayor Doherty stated it's based off estimates the Business Administrator received. Mr. Seebeck feels a couple hundred thousands of dollars for playgrounds seems expensive. Mayor Doherty stated the equipment is expensive as well as the ground surface. Mr. Seebeck stated he hopes Council member Brennan is successful with his plan to reduce plastic bags.

Michael Druz, Ocean Avenue, would like a full fence installed at the playground at Maclearie Park.

Marcus Kirschenbaum, Wall Township, discussed the approaches used to determine property assessments. He stated he has letters from the 1950's that says the cost approach doesn't exist. He stated the assessments are screwed up because the wrong approach was used. He had an issue with Mayor Doherty not allowing him to speak at the town hall meeting.

Mayor Doherty made a motion to close the public session, which was seconded by Council member Nicolay and approved unanimously.
