<u> WORKSHOP DISCUSSION:</u>

- CDL Loan
 - Ms. Connolly and CFO Robbin Kirk announced the Federal Government has officially stated the 4.4 million CDL loan taken after Hurricane Sandy has been forgiven. The Borough does not have to pay it back. Borough Auditor Chuck Fallon was also present and confirmed this.
- Parks Commission
 - Ocuncil member Levis would like to do an ordinance creating a parks commission which would be an advisory commission like the Harbor Commission. He referenced Cranbury Township's ordinance. Council member Walsifer was concerned about them dictating to DPW what work needs to be done. Mr. Cannon stated the ordinance could clearly outline their role. Some towns have a provision where the commission only meets quarterly and submits recommendations on improvements at budget time instead of daily. The Mayor and Council were okay with moving forward on this ordinance.
- Council member Walsifer stated there have been reports of issues at the gazebo at Silver Lake with people damaging the gazebo. He suggested we collect a security deposit. Ms. Connolly suggested at least charging an application fee. Mayor Magovern stated we used to charge a fee and asked why it was stopped. He would like to charge a fee and a deposit. Ms. Connolly stated we could set that up for 2019.
- Council member Walsifer asked about the storm water ordinance previously discussed. Ms. Connolly stated she has been working with DPW to address some current issues and working on preparing an ordinance to present to the Council soon.
- Council member Levis stated he would like to be involved with the hiring process for CFO because he feels it is an important position. Mr. Cannon read the borough ordinance that outlines the hiring procedure. Mayor Magovern stated he makes the final decision on who to put up for appointment and the Council will vote on it. He also stated he feels we should hire a firm to assist with the hiring process as well.

Council member Levis: Fall Festival is this weekend. October 10th is the senior lunch at D'Jais.

Council member Walsifer: Progress.

Council member Brennan: Attended his first Tourism Commission meeting. Fall Festival is entirely in the plaza this year and it looks like it will set up nicely. Received a complaint from an Ocean Avenue business owner

about the dunes going up too early. Would like to look at this for next year to see if there is a way to make the beach more accessible if we must prepare for an early storm. Council member Levis agreed we need to investigate whether the dunes scientifically work.

Mayor Magovern: Thanked DPW for sprucing up Silver Lake. Fuggario Park rededication is October 13th. The Shillelaghs are hosting a 5k on the same date to benefit the education fund for the children of Deidre Siecke, daughter of former employee Sharon Day. The bathrooms on the boardwalk will close October 14th. The Historical Society has a new display in the lobby about the schools.

<u>PUBLIC SESSION:</u> Public Session on resolutions only on the Agenda. We will continue to have a Public Session at the end of this meeting.
