# RESOLUTION OF THE BOROUGH COUNCIL OF THE BOROUGH OF BELMAR, COUNTY OF MONMOUTH, STATE OF NEW JERSEY, APPROVING AND AUTHORIZING THE HIRING OF HUNTER VOJTKO

**WHEREAS**, the Borough of Belmar is governed by N.J.S.A. 11A:1-1 et. Esq., the Civil Service Act, and the rules and regulations established pursuant to this act; and

WHEREAS, P.L. 2021, c.7 provides for the Civil Service Commission to exempt a person from the requirement to take an examination for an entry-level law enforcement position provide the individual has successfully completed a full Basic Course for Police Officers training course at a school approved and authorized by the New Jersey Police Training Commission; and

WHEREAS, P.L. 2021, c.7 also provides that a municipal police department may hire a person exempt from the Civil Service requirement to take an examination for an entry-level law enforcement position upon adoption of a resolution by the governing body authorizing such hiring and the adoption of a conflict on interest and nepotism policies; and

**WHEREAS**, the Borough has previously a conflict of interest policy (Section 1, Borough of Belmar Employee Handbook) and a nepotism policy (Section 2, Borough of Belmar Employee Handbook) as provided in the Boroughs Employee Handbook; and

**WHEREAS**, the Chief of Police has recommended the Borough affirmatively "opt in" and authorize such hiring to provide for the selection of a qualified individual who has completed the necessary training required by the New Jersey Police Training Commission; and

**WHEREAS**, the Chief of Police has further recommended the provisional appointment of Hunter Vojtko as a Police Officer pursuant to this exemption.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Borough of Belmar, in the County of Monmouth, State of New Jersey, as follows:

- 1. the Borough of Belmar is hereby authorized to participate in the program to hire persons exempt from the Civil Service examination process for entry-level law enforcement positions provided the individual has successfully completed a full Basic Course for Police Officers training course at a school approved and authorized by the New Jersey Police Training Commission.
- 2. Hunter Vojtko is hereby appointed to the position of Police Officer on a provisional basis effective January 1, 2023 and conditioned upon issuance of the required certification by the New Jersey Police Training Commission and approval of the New Jersey Civil Service Commission. The appointee shall be compensated in accordance with the collective bargaining agreement between the Beorough and the P.B.A. Local No. 50.

- 3. The Chief of Police and Borough Administrator are authorized to execute all documents necessary to effectuate participation in this Civil Service exemption program and the provisional appointment of Police Officer Hunter Vojtko
- 4. The Borough Clerk is directed to transmit a certified copy of this resolution to the Chief of Police, Borough Administrator, and the New Jersey Civil Service Commission.
