# **WORKSHOP DISCUSSION:**

Mayor Walsifer stated we had put the ordinance for the parking meter fees on the last meeting but after further review most of the money would still go to the beach utility and not the parking fund. Plus, if we adopted it tonight and waited the 20 days for it to go into effect then there would only be 8 days left of the new fee. We are going to table the ordinance and revisit it at a later date to get it ready for next summer.

Mayor Walsifer explained Resolution 2019-166. A lot of developers have contacted us about development projects. We want everything to be above board so we will seek proposals and review them all at a public meeting. If they are bad, we won't do anything. If they are good, we will look into them further. Councilman Brennan would like to make sure the public has input. Councilwoman Wann added that the proposals are not binding, we just want to see what is out there.

<u>APPROVAL OF MINUTES:</u> Councilwoman Wann made a motion to approve the minutes of the July 23, 2019 meeting, which was seconded by Councilman Brennan and approved unanimously.

### REPORTS OF COUNCIL:

Councilman Carvelli: BBP welcomed new business the Steak Stand. Has started a video restaurant tour with Media Director John Sabia. Two weeks ago, he and Councilman McCracken spent four hours with DPW touring buildings and learning their operations. Police Explorer Program is going to start up again soon.

Councilwoman Wann: Thanked DPW for responding to issues she hears about so quickly. Thanked Code Enforcement for addressing a safety issue on Route 35. Has seen a lot of people fishing at Silver Lake. Mike Campbell, DPW Director, stated the lake was restocked with fish after Hurricane Sandy. The State will come down in September to see if can replenish again. Councilwoman Wann asked why the street sweepers don't go out after 7 am when the cars have moved. Mr. Campbell stated they start working at 3 am to do the Plaza, Main Street, and Marina during the summer when the town is very busy. Community Policing program is running really well.

Councilman Brennan: The Shark River Cleanup Coalition is having a cleanup on August 17<sup>th</sup>. Appreciates all the kind words given to his wife who broke her arm hiking on vacation.

Mayor Walsifer: Weekends have been great. Weather has been good. All of the employees have been really stepping up. August 30<sup>th</sup> the Post Office will be dedicated to Doctor Walter Macfee by Congressman Chris Smith. Tourism Commission is looking into a food truck festival in October instead of the Fall Festival.

### **PUBLIC SESSION:**

Sandy Caputo, Surf Avenue, spoke about people playing ball on the beach again. She did see a lifeguard get off the stand and speak to someone but doesn't understand why they can't just blow their whistle. Mayor Walsifer stated the ordinance needs to be changed. Will discuss it with the Chief and Head Lifeguard in the off season.

Mark Pheiffer, 319 5<sup>th</sup> Avenue, this past weekend the lifeguards at 5<sup>th</sup> Avenue did really great managing the rip tide. Asked if we will revisit charging for parking in the marina. Mayor Walsifer stated we will be looking into that. Also, will be looking into changing the meter kiosks. Mr. Pheiffer also stated we need to look at the signage for no tents on the beach. Spring Lake has a sign we need. Mr. Kirschenbaum stated we did change the ordinance this year. Andrew Huisman, Chief of Police, stated the new ordinance was narrowed down and hasn't see many complaints.

Tom Volker, 527 8<sup>th</sup> Avenue, thanked the Mayor and Council for what they have been trying to do to keep the taxes low. Questioned why his tax bill did not say "Advice Only" like it did in the past. Ms. Claudio explained there was a computer glitch with the software company and if his taxes are paid by his mortgage company then it will continue to be done that way. Mr. Volker asked about the program to help seniors by having them check in with the police. Suggested that info be passed around.

Jim Bean, 16<sup>th</sup> Avenue, stated the seniors are asking if their petition is going to be considered. Chief Huisman stated letters have gone to the State requesting additional meetings to discuss options. Mr. Bean asked if speedbumps are a viable option. Chief Huisman stated the State will not allow them. Mr. Bean asked about where a parking garage would go. Mayor Walsifer stated it would be at the current Borough lot and everything will be done above board and open to the public.

Maria Rodinaro, Pinetree, asked if the credit card machines are working. Mayor Walsifer stated they aren't working, it's been a problem the whole summer. The bandwidth isn't enough with the large amount of people. Working with Verizon to address it. Ms. Rodinaro stated there have been three mass shootings in the country since the last meeting. Thinks it's important that the Mayor and Council make it known that we don't support hate. It's good that the Police Department has a presence.

Councilwoman Wann made a motion to close the public session, which was seconded by Mayor Walsifer and approved unanimously.
