WORKSHOP DISCUSSION:

Mayor Walsifer stated we received two letters from the State of NJ. The first letter states our trip to Washington D.C. was unsuccessful and they will not be paying us the \$600,000 from the grant for the Lake Como project. Will be working with Mr. Dasti on some other options to recoup that money. The second letter states that FEMA over paid us \$1,700,000.00 and they want their money back.

Mayor Walsifer explained the two bond ordinances. The one ordinance is to cover the \$600,000 and other fees that may occur during the closeout of the Lake Como project. It also includes \$1 million to put money back into the beach utility per D.C.A.

Mr. Kirschenbaum stated the Borough will be receiving \$92,000 for a Maclearie Park grant that the Borough was in jeopardy of losing because nobody from the Borough responded to the County's numerous requests. Also working on a National Boating Infrastructure grant from 2015 that the Borough was in jeopardy of losing.

APPROVAL OF MINUTES: Councilwoman Wann made a motion to approve the minutes of the September 3, 2019 meeting, which was seconded by Mayor Walsifer and approved unanimously.

REPORTS OF COUNCIL:

Councilman Carvelli: Harbor Commission met. Slip occupancy is just over 60% which is better than years past. Also discussed whether or not fuel prices are competitive and the 2020 boat show. The ADA Committee meets this Thursday. The San Gennaro festival this past weekend was great. The police explorers meeting is this Saturday. Autism Beach Bash had great weather for their event. The County painted all the crosswalks on Main Street from 8th to 16th Avenues. The State will paint crosswalks on Main Street between 7th and 5th Avenues as well, also will be installing countdown timers.

Councilman McCracken: It's a shame the Veterans Day beach bash was cancelled and hopes it will be offered again. The San Gennaro festival was organized in house without the use of a marketing firm. Several business owners stated they benefited greatly from the festival. The Belmar Housing Authority had a 9/11 remembrance ceremony. Thanked them for hosting the event. Also visited the Jersey Shore Running Club event on 9/11. There is caution tape at the 8th Avenue playground because there was a ladder with rust that needed to be fixed. Mr. Campbell inspected all the playground equipment and got the manufacturer to replace rusty parts free of charge.

Councilwoman Wann: Thanked Mr. Campbell and Chief Huisman for a safe and efficiently run San Gennaro festival. Community Policing is having a wrap up meeting soon.

Mayor Walsifer: San Gennaro festival went very smooth. DOT met with State and Police Chief today regarding the 8th Avenue crossing. Chief Huisman stated they had a very good meeting with DOT and NJ Transit. It was suggested the crosswalk will be moved a short distance to the east and have a signal crosswalk with lights. Also looking at the intersection of 8th Avenue. Will have a straight and left-hand turn signal and countdown timer. They will review our suggestions and get back to us.
