#### **PUBLIC SESSION:**

Anita Pecorreli, River Ridge Apts, Friends of the Belmar Library has been rebooted. They are concerned about the lease for the community center on 7<sup>th</sup>.

Bobbi Henniger, 8<sup>th</sup> Avenue, asked if there will be a review of the outdoor dining ordinance. There are a lot of businesses taking advantage of the ordinance. Concerned about the structure at Flames.

Lisette Velez, 413 13<sup>th</sup> Avenue, street is extremely dark. Concerned about people trying to break in to houses in her block. Also, would like to get a copy of the property maintenance ordinance.

Mark Nesra, owns a small business that does work in town. Has been parking his trucks at the 13<sup>th</sup> Avenue lot because he has seen other commercial vehicles there. Thinks businesses should be notified when they move in that there are grants available to them. Should be told where can park commercial vehicles. Suggested a permit system to generate revenue for those that need a place to park.

Claire Hayner, 221 18<sup>th</sup> Avenue, NJ Run for the Fallen will be coming through Belmar. Gave a background on the organization and how the run works.

Missy Manley, Senior Building, has been two months since accident in the crosswalk. It is a quality of life and safety issue. There are many simple and inexpensive solutions. Mayor Walsifer stated it is a state road, the Chief of Police is in contact with them to address it. They will not allow us to do speedbumps. Mr. Kirschenbaum stated they will be meeting with DOT and NJ Transit on September 17<sup>th</sup>.

Jim Bean, 16<sup>th</sup> Avenue, agreed with Ms. Manley. He would like speed bumps put down until the State comes up with a better solution. Mayor Walsifer stated we are working on it, but it is a state road which Mr. Bean is aware of. Mayor Walsifer and Mr. Kirschenbaum stated the Borough cannot break the law. Councilman Carvelli stated we could remove the crosswalk and then they would have to walk down to 8<sup>th</sup> and Main Street to cross.

Councilman Brennan made a motion to close the public session and adjourn the meeting, which was seconded by Councilwoman Wann and approved unanimously.
