WORKSHOP DISCUSSION:

- Mayor Walsifer announced letters will be going out with final numbers on the Sidewalk Assessment Program. Participants will have the opportunity to schedule a meeting to review.
- Mayor Walsifer announced the town wide yard sale will be May 22nd and 23rd and September 25th and 26th.
- Mayor Walsifer and Chief Scott announced several police officers are being promoted. Swearing in will be Saturday at 10 am at the Huisman Gazebo.
- Barry Trogu, Recreation Director, discussed upcoming recreation programs for the summer.
- Councilman McCracken asked if the snack bar at Dempsey Park could be used. Mr. Kirschenbaum stated it is in disrepair.
- Ryan Dullea, Fire Official, explained the EMS resolutions on the agenda.
- Mayor Walsifer thanked Police, Fire and EMS for handling the Lake Como fire today.

Mayor Walsifer: Thanked the Easter Bunny for delivering treats around town. The new fire truck is now in service.

Eugene Creamer, 4th Avenue, suggested adding paid parking at Schroeder Park since Avon is eliminating parking spaces.

John Walsh, 1101 B Street, asked about Walgreen's curb side signs. Mayor Walsifer stated those are permitted during the pandemic.

Sharon Russell Fowler, 11th Avenue, gave an update on Library programs.

Gerald Buccafusco, 5th Avenue, suggested having budget meetings like Manasquan is doing. Asked when the public will have input on the Mediterranean project. Mayor Walsifer stated if they make changes to the proposal there will be another presentation.
