Councilwoman Wann: Monday started the game day for seniors at Taylor Pavilion. Will also have monthly coffee meeting for them. ADA Committee met last week. The library has two programs: Elder Care and Disability Law for families with special needs children.

Mayor Walsifer: Dine & Discover is this Sunday. October 14th will be the first senior lunch. The Borough is hoping to receive a grant from the County in the amount of \$135,000 to do sidewalks and ramps in Belmar Plaza. The Borough is also receiving \$28,715.31 for Hurricane Isis.

PUBLIC SESSION:

Dolphin McKinley, Ocean Township, asked about the status of the skatepark and how he can help.

Anthony Dameca, Toms River, thinks the Borough would qualify for a \$25,000 grant from the Tony Hawk Foundation for the skate park. He questioned the lack of maintenance on the skate park. Mayor Walsifer stated there has been a lot of maintenance.

Mr. McKinley stated he will research other grants and inform Mr. Kirschenbaum of them.

Tom Volker, 527 8th Avenue, was thankful for opening Taylor Pavilion for the seniors. He asked if the train station structure was ever fixed. Mr. Kirschenbaum will contact NJ Transit to find out.

Maria Rondinaro, 1246 Pinetree, was concerned that the Code Red regarding the No Knock Registry did not list those that are exempt from the soliciting rules.

Jane Salmon, Wall Township, stated she has a group of 500 people in support of saving the skate park.

Kyle Rizzitello, 14th Avenue, was thankful for the pink flag in the plaza and the pink line on Main Street.

Mike Suhocki, 112 18th Avenue, questioned the new billing for water/sewer since he has a multifamily.

Mayor Walsifer explained we removed the \$50 surcharge and charge each unit \$88.95 but they receive 5000 gallons of water with that, so it is fair for everyone including the condos. Mr. Suhocki felt billing should be

based solely on usage.

Councilman Brennan made a motion to close the public session and adjourn the meeting, which was seconded by Councilwoman Wann and approved unanimously.
