WORKSHOP DISCUSSION:

Ms. Claudio stated the 2021 Best Practices Checklist was sent to the Council for their review. The Borough scored 21 out of 23 which means there will be no loss in aid.

PETITIONS: None

APPROVAL OF MINUTES: Councilman Brennan made a motion to approve the minutes of the October 19, 2021 meeting, which was seconded by Councilwoman Wann and approved unanimously.

REPORTS OF COUNCIL:

Councilman Carvelli: Finance Committee has been busy. Planning Board hasn't met. DPW did a good job cleaning up the sand from the storm. Veteran's Day service is Thursday at 9:30 am.

Councilman McCracken: Announced upcoming events for the remainder of the month and the first week of December. The Borough received \$712,000 in grant money for the Lake Como project. Fifteenth Avenue paving is complete except for striping. Sixteenth and 12th Avenue projects are still ongoing. Housing Authority working on getting a new landscaping company and making the building safe.

Councilman Brennan: Thanked DPW and all the volunteers who helped out with the beach plantings. DPW is working on a plan to assess sand damage and how to address.

<u>PUBLIC SESSION:</u> Public Session on resolutions only on the Agenda. We will continue to have a Public Session at the end of this meeting.

Gene Creamer, 4th Avenue, asked if the tax sale includes water/sewer bills. He was concerned that the major utility companies are not requiring people to pay due to the COVID-19 pandemic but yet the Borough is. He asked if there is federal funding available to the Borough to cover floating these outstanding fees.

Mr. Varga stated the Borough is not in a position where they can not collect the money like the major utility companies are.
