### **WORKSHOP DISCUSSION:**

Greg Kapalko, Brett Yarusi and their architect Brian Berzsinkis gave a presentation on the Eastport project at 508 Main Street. The plans call for a new building containing two retail spaces and two condos on the first floor and additional condos on the second and third floors with interior parking. The façade will mirror the neighboring building. All units will become condominiums. Christine Bell, Borough Planner, stated the project is compliant with the Seaport Redevelopment plan. They also meet the parking requirements. Mr. Kapalko stated there will be additional street parking added.

Councilwoman Kinney and John Sabia gave a tutorial on the Nixle System, which will also be available on the website.

## **PUBLIC SESSION:**

Linda Sharkus, 4<sup>th</sup> Avenue, asked about community policing. Mayor Walsifer stated they are working on scheduling meetings.

Mark Pheiffer, 319 5<sup>th</sup> Avenue, suggested block captains work on getting people registered with the Nixle system.

Gene Creamer, 4<sup>th</sup> Avenue, was appreciative of the Arbor Day proclamation. He asked if fluoride is added to our water. Billy Musto, DPW, will find out what chemicals are added.

Jane Salmon, Wall Township, asked for an update on the skatepark. Mayor Walsifer stated we are looking at all our options. She felt the skatepark could be repaired for \$10,000. Mayor Walsifer informed her we have to follow the guidelines from our insurance company. Councilman Carvelli suggested she reach out to Wall Township to see if they could build a skatepark since that's where she lives. Mr. Vargas explained the liability for the skatepark.

Kyle Rizzitello, 14<sup>th</sup> Avenue, would like to do a walk through of Maclearie Park with the Council to show them what needs to be fixed. Would like to see L Street repaved and potholes on 12<sup>th</sup> and 13<sup>th</sup> near the railroad fixed. Mr. Musto stated they will be working on potholes next week, weather permitting.

Gerald Buccafusco, 409 5<sup>th</sup> Avenue, stated he will be submitting an OPRA request to get the correspondence from the insurance company regarding the skatepark.

Maria Rondinaro, 1246 Pinetree Way, suggested looking into grants for the skatepark. Councilman Brennan made a motion to close the public session and adjourn the meeting, which was seconded by Councilwoman Kinney and approved unanimously.
