RESOLUTION PERMITTING SPECIAL EVENTS

WHEREAS, applications have been received by the Special Events Committee as per Ordinance 16-14.4 “Permits and Special Event Permits;” and

WHEREAS, said applications have been reviewed by the Special Events Committee and by the Borough Council; and

WHEREAS, the following events are recommended for approval with conditions if applicable:

Special Olympics Half Marathon: Saturday, April 21st, 2018. Event takes place on the Belmar Boardwalk. No additional Borough resources are required.

Autism Family Services Beach Bash, Thursday September 6th to Sunday September 10th, 2018 on Belmar Beach between 6th and 8th Avenue. Area will be left in the same condition in which it was found. No additional Borough resources are required.

Walk to end Alzheimer’s, Saturday October 20th, 2018. Event will take place on Belmar Boardwalk. A payment of \$500.00 must be made to the Borough of Belmar no later than September 1st, 2018.

DQ Events Triathlon, Sunday August 5th, 2018. Event takes place on Belmar Beach, Belmar Boardwalk, Ocean Avenue and Silver Lake Park. Organization must inform all residents impacted by the event at least one week prior to the event, either through mailing or a door to door drop off. Event organizers must meet with the Belmar Police and the Department of Public Works two weeks prior to the event to review all components of the event. A payment of \$5000.00 must be made to the Borough of Belmar no later than July 1st, 2018.

Belmar Five, Saturday July 14th, 2018. Event takes place on Ocean Avenue and Streets throughout Belmar Silver Lake Park. Organization must inform all residents impacted by the event at least one week prior to the event, either through mailing or a door to door drop off. Event organizers must meet with the Belmar Police and the Department of Public Works two weeks prior to the event to review all components of the event. A payment of \$5000.00 must be made to the Borough of Belmar no later than June 1st, 2018.

Walk MS, Sunday April 29th 2018. Event begins and ends at Bar Anticipation. Race beginning time has been changed to 10:00am. Streets will begin to open at 11:00am. All other conditions are the same as in prior approval.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Belmar that permission is granted for the special events as noted above with conditions if cited.
