Group and Dynamic Sandblasting must be rejected; and

WHEREAS, the bid submitted by America Construction Group and Dynamic Sandblasting provides that neither has been in business for five years in the tank painting field, and neither has provided evidence that its company has performed the "specified type cleaning and painting on at least fifteen (15) tanks of similar design" both defects being in direct contradiction to Section 9850.§1.02(a)(1) which required:

All cleaning and painting work covered by these Specification shall be performed by a <u>firm</u> having at least five (5) years successful experience in the tank painting field, and shall have performed specified type clean and painting on at last fifteen (15) tanks of similar design.

WHEREAS, Belmar finds that these defects are material and cannot be waived; and

WHEREAS, as a result thereof, the apparent lowest responsive, responsible bidder is

Allied Painting, Inc. for a proposed price of \$387,950.00.

WHEREAS, the bid documentation submitted on behalf of Allied Painting, Inc. has been

reviewed by Belmar's professional and administrative staff and found to be acceptable and in

accordance with Belmar's budgetary constraints; and
