## DESIGNATING THE MONTH OF OCTOBER IN EACH YEAR AS "BREAST CANCER AWARENESS MONTH"

**WHEREAS**, National Breast Cancer Awareness Month (NBCAM) educates women about the importance of early detection for breast cancer. Since NBCAM's inception, mammography use has doubled, and breast cancer death rates have declined. Still, many women do not utilize mammography at regular intervals.

**WHEREAS**, In recognition of the fact that mammography is the best available method of detecting breast changes that may be cancer, long before physical symptoms can be seen or felt, and that breast cancer deaths could decline further if all women age 40 and older received mammograms at regular intervals,

**WHEREAS**, October 2021 marks the 37<sup>th</sup> Anniversary of National Breast Cancer Awareness Month, which is dedicated to increasing awareness of breast cancer issues, especially the importance of early detection; and

**NOW, THEREFORE, BE IT RESOLVED**, the Mayor and Council of the Borough of Belmar, County of Monmouth, State of New Jersey, do hereby proclaim October as National Breast Cancer Awareness Month. All women and their families in the Borough of Belmar, County of Monmouth, and State of New Jersey are urged to get the facts about mammography and breast cancer detection.

### RESOLUTION PERMITTING SPECIAL EVENTS

**WHEREAS**, applications have been received by the Special Events Committee as per Ordinance 16-14.4 “Permits and Special Event Permits;” and

**WHEREAS**, said applications have been reviewed by the Special Events Committee and by the Borough Council; and

**WHEREAS**, the following events are recommended for approval with conditions if applicable:

Belmar St. Patrick’s Day Parade: Sunday, March 6, 2022. Event will take place on Main Street in beginning at Noon. Event will begin in Lake Como and proceed along Main Street. A viewing stand will be parked at the intersection of Main Street and 9<sup>th</sup> Avenue. Parade will end at 5<sup>th</sup> Avenue and Main Street. Costs for Borough resources will be assigned closer to the date of the event.

Belmar Dine & Discover: Sunday, March 13, 2022. Event will take place in downtown Belmar. No additional Borough resources are required.

Belmar 150<sup>th</sup> Celebration “Field of Dreams” Day: Saturday, May 14, 2022. Event will take place at Belmar Memorial Field. Numerous activities including a plaque dedication, a baseball game and a movie in the evening will take place. Borough resources will be assigned closer to the date of the event.

Borough Town Wide Yard Sale: Saturday, and Sunday May 14 & 15, 2022. Event will take place throughout Belmar. No additional Borough resources are required.

New Jersey Seafood Festival: Friday, Saturday and Sunday, May 20-22, 2022. Event will take place in the Pyanoe Plaza and Pyanoe Plaza Parking lot. Event will begin at 4:00PM on Friday evening and end at 8:00PM, Saturday 11:00AM to 8:00PM and Sunday 11:00AM to 6:00PM. Costs for Borough resources will be assigned closer to the date of the event.

Friday Night Concerts in Pyanoe Plaza: Fridays May 27 to August 26, 2022. Events will begin at 6:00PM and end by 8:30 PM every Friday. Event is a fair-weather event, with no rain dates. No additional Borough resources are required.

Belmar Farmers Market: Event will take place at Memorial Field on Main Street between 12<sup>th</sup> and 13<sup>th</sup> Avenue. Event will occur weekly and begin at 4:00PM and end at 8:00PM. This is a rain or shine event. Event dates are as follows: June 1, 8, 15, 22 & 29, July 6, 13, 20 & 27, August 3, 10, 17, 24 & 31 and September 7 & 14, 2022. No additional Borough resources are required.

New Jersey Sandcastle Contest: Wednesday, July 13 2022 (rain date Thursday July 14<sup>th</sup>). Event will take place on Belmar Beach between 17<sup>th</sup> and 19<sup>th</sup> Avenue. Event will begin at 8:00AM and end at Noon. No additional Borough resources are required.

Belmar Movies on the Beach: Thursdays, July 14, 21 & 28 August 4, 11, 18 & 25, 2022. Movies begin at dusk on Belmar Beach between 7<sup>th</sup> & 8<sup>th</sup> Avenue. Event is a fair-weather event with no rain dates. No additional Borough resources are required.

Belmar “Founders Day” Celebration: Wednesday, August 31, 2022. Event will begin at 10:00AM at the Borough Municipal Building and proceed along Main Street to 10<sup>th</sup> Avenue. Borough resources will be assigned closer to the date of the event.

Belmar 150<sup>th</sup> Birthday Celebration: Saturday, September 10, 2022. Event will take place at Silver Lake Park and in the Taylor Pavilion. Event will consist of activities throughout the day. Borough resources will be assigned closer to the date of the event.

Belmar Pro Surf, Wednesday-Sunday September 14 – 18, 2022. Event will take place on Belmar Beach between 15<sup>th</sup> and 17<sup>th</sup> Avenue. Event organizers will leave the beach in the same condition in which it was found. Borough resources will be assigned closer to the date of the event.

10<sup>th</sup> Annual Feast of San Gennaro: Saturday & Sunday September 17 & 18 2022. Event will take place on Main Street between 10<sup>th</sup> and 12<sup>th</sup> Avenue. Event will take place between 11:00AM and 6:00 PM daily. Main Street between 10<sup>th</sup> and 12<sup>th</sup> Avenue will be closed throughout the event. Borough resources will be assigned closer to the date of the event.

Borough Town Wide Yard Sale: Saturday, and Sunday September 24 & 25, 2022. Event will take place throughout Belmar. No additional Borough resources are required.

Borough of Belmar Annual Halloween Costume Contest and Parade: Friday, October 28, 2022. Event begins in the municipal gym and the parade takes place on Main Street. No additional Borough resources are required.

Annual Christmas Tree Lighting: Friday, December 2, 2022. Event will take place in Pyanoe Plaza and activities will begin at 5:30PM. Borough resources will be assigned closer to the date of the event.

Menorah Lighting: Friday, December 19, 2022. Event will take place in Pyanoe Plaza at dusk. No additional Borough resources are required.

ASPCA Doggy Paddle Plunge: Saturday, November 27, 2021. Event will take place on Belmar Beach between 17<sup>th</sup> & 19<sup>th</sup> Avenue. Participants will adhere to all Borough ordinances and leave the beach in the same condition in which they found it. Organizers will reach out to Belmar Water Rescue to coordinate any necessary services. No additional Borough resources are required.
